Campers are allowed to bring both their skateboards and roller blades each day. One of our staff members will be on roller blades throughout the week. Full protective equipment will be required for all participants (helmet with chin-strap, wrist guards, kneepads, and elbow pads). Staff members will be required to wear helmets just like the kids. Throughout the week, campers will be challenged progressively, encouraging them to do more difficult moves, while using all apparatuses safely. All campers will receive a camp T-shirt on Friday as well as an ice-cold bottle of Gatorade daily.

On Friday, we'll be hosting an X-game's style competition. All participants will be judged competing in a variety of categories suited for their age. Winners will be determined based on their improvement made throughout the week.
